
Dear ICRF submitters,

I would like to take this opportunity to assist you in the process of proposal submission to the ICRF through their SurveyMonkey system.

Yossi Edery (josefede@tauex.tau.ac.il) will handle your applications this cycle.

At first, when you log in and start preparing your application, **please add the e-mail address** (<u>liatgrum@tauex.tau.ac.il</u>) in the "Add collaborator" option on the left. This will allow Yossi to review your proposal and make sure it complies with the ICRF guidelines.

Please see, for instance, an application in the Acceleration Grant mechanism:



Important notices:

- Due to the new VATAT guidelines, it is advisable to budget yourself (PIs) with Tosefet A at the rate of 25% of the yearly sum (in Project grants, for example, a PI can ask for up to 15K USD per year for salary). Please note that PIs who do not budget themselves may lose some of the Tosefet B.
- Please note that other than RCDA mechanism which allow up to 1,000 USD for travel costs for the whole period of the research project, you are not allowed to budget travel costs.
- Submitters to the Professorship mechanism should make sure that they will not serve in any administrative position (such as dean or department head) during award period.
